- The farmer(s) who lease this property must provide a certificate of insurance for at least \$1 million general public liability insurance covering claims for personal injury, loss of life and property damage. The farmer will also be required to have Workers Compensation insurance as required by North Carolina law upon lease agreement signature (not required at time of bid).
- The Bid is subject to County Commissioner approval at its regular monthly meeting in January 2024.
- For Economic Development purposes, for sale signage will be displayed on county leased properties.
