#### **Expectations of Youth Enrolled in Our Camps**

- Respect the facility and all program materials and resources.

#### **Camp Registration and 4-H Online Enrollment**

Registration information and links to all programs can be located at go.ncsu.edu/nashcountysummer. 4-H programs are open to youth who are 5-18 years of age by January 1<sup>st,</sup> 2024.

Participants must enroll in Nash County 4-H in the 4-H Online membership management system at v2.4honline.com. As part of the membership enrollment process, parents are required to complete and attest to the following forms to enroll their child(ren) in 4-H camps and associated programs.

- Health History & Authorization Form
- 4-H Code of Conduct

- NC 4-H Photo & Media Release Form

#### **Program Schedule/Pick Up and Drop Off**

A camp description is in our program booklet with things needed and the location for drop off. Eventbrite will send you a reminder a few days before the camp. 4-H staff will do their best to begin and end on time each day. We ask that parents arrive on time as well. Please make sure you sign your child in and out at each day of camp. Pick up and drop off MOST days will be at the Nash County Agriculture Center unless noted in our program booklet. If you must cancel please notify Amy Ormond at <u>amy\_ormond@ncsu.edu</u> so we will not be expecting your child.

#### Camp Fees



Fees vary based on the summer program. Fees are to be paid by cash, check or via Eventbrite link using an acceptable card payment. Return check fees are \$30.00. No refunds will be made within 2 weeks of the camp unless another child can take the spot. Eventbrite will NOT return their fees if payment was made by credit card.

#### Medical & Health Protocols

The Nash County 4-H is sensitive to the health and physical needs of the youth. All



participants must complete the Health Form in 4-H Online and it is the parent or guardian's responsibility to ensure the information is up to date and the instructors understand your child's needs. Also, if your child absolutely requires medicine during camp please make sure the 4-H Staff is aware and our required form is complete (forms are on file at the office) If the camp is outside please make sure you provide sunscreen and bug spray if your child requires

those items. We are not responsible for sunburn/insect bites.

#### What NOT to Bring to Camp

Ear Pods, computers, phones, other electronic devices, toys, valuable jewelry or articles of clothing, matches, lighters, weapons, and any illegal substances or items



#### Dress Code

Closed- Toe shoes are required each day for safety purposes. We DO NOT allow the following: halter tops, clothing with inappropriate pictures or profanity, short shorts, saggy pants or swimsuits.

#### **Bullying & Disrespectful Behavior**

Our 4-H program does not tolerate bullying. Participants and/or parents are encouraged to report any bullying or disrespectful behavior to the program staff so that we can address it immediately and act to keep everyone safe. Bullying is against the 4-H Code of Conduct.
